Terms and Condition

The following terms are basic conditions upon which floor space is booked which are binding on the applicant until the signing of the Agreement to sell-and-leaseback. GENERAL TERMS

- 7. Any dispute arising out of or in relation to the booking of the floor space or the subjects metter hereof, if not resolved within 15 days, shall be referred for arbitration under the 1940 or any other law for the time being in force.

PAYMENT TERMS

- 8. Full and final down payment must be deposited, in part of our lump sum, within 15 days of the payment of taken money.
- 9. Payment by cash, or pay order is accepted. Any payment in a currency other than Pakstani Rupees will be subject to conversion based on applicable bank rates.
- 10. All bank instruments must be made payable to 'Greenish Builders' We shall not be responsible for any payment made in any other name.
